6.1 Ontario Clean Water Agency (OCWA) – Brad Sweet, Aimee Hennessy, and Brian Symondson

Aimee Hennessy, Brad Sweet, and Brian Symondson provided an overview of the services Ontario Clean Water Agency (OCWA) provides to the Town of Deep River, through their operation of the Town's Wastewater Treatment Facility and the Water Treatment Facility.
